Dear Parent,

We would like to express our gratitude for your support to the school at all times. Earlier, as per order of DOE dated 17.10.2017 the school had “**interim fee hike**” in Tuition Fee only by 7.5% w.e.f. 1.4.2017 and 15% w.e.f. 1.7.2017 on a/c of implementation of 7th Pay Commission vide circular of the school dated 27.12.2017 (can be seen at school website) and revised fee was charged from students till June 2018.

The increased fee of 15% charged was **withheld** as per the order of DOE 13.4.2018. Accordingly, the school had roll back increased fee of 15% w.e.f. 1.7.2018 and school is at present accepting fee as per 2015-16 fee schedule.

Now as per recent Order dated 15.3.2019 passed in W.P.(c) 4374/2018 and CM No. 16982/2018 of Hon’ble High Court of Delhi, the Hon’ble High Court has QUASHED AND SET ASIDE the impugned Order dated 13.4.2018 of DOE and now the interim fee Hike under the order 17.10.2017 of DOE would operate immediately in favour of all Private unaided schools, without requirement of any prior approval.

Parents are therefore requested to make payment of fee arrears of increased fee of Tuition Fee only for the period July 2018 till March 2019 (9 months) as per schedule (available at school website) by 31.3.2019.


